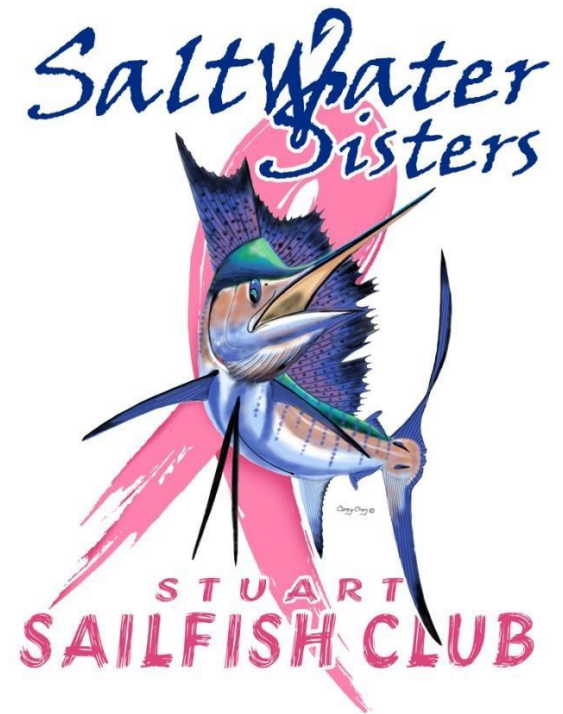

### Please Read & Sign To Be Eligible To Fish

All registered anglers and non-registered occupants of registered boats enter and participate in this Saltwater Sisters Fishing Tournament (SWS) voluntarily and at their own risk. In consideration for the SWS's acceptance of his or her entry, each registered angler, for his or her heirs, executors, and administrators, agrees to release, holds harmless and indemnify Pirates Cove Resort & Marina, SWS, its officers, directors, agents, polygraph examiners, sponsors, donors, the city and county where the event is held, and all other persons connected directly or indirectly with the operation of the tournament, from and against any and all liabilities, claims, actions, damages, costs, fees or expenses which he or she may have against any above described party, or which his or her captains, crew members, family members, companions or non-registered occupants of their boat may have, arising out of or in any way connected with his or her participation in this SWS, including any injury or death suffered by any registered angler, boat captains, crew members, family members, companions or other occupants of any boat, and including any damage to vessels and equipment, which occurs during or in conjunction with the event. Each registered angler understands and agrees that this release specifically includes and waives any claims based on libel, slander, negligence, action or inaction of any above-named party. Each registered angler further understands and agrees that this release specifically includes and waives any claims arising from the use of SSCF's use of any photographs and video from SSCF's administration of or interpretation of any polygraph. It is further agreed by all parties that each captain has the ultimate responsibility to determine if conditions are unsafe for his vessel. If each captain is not satisfied that the conditions are safe for his Vessel, that captain shall not participate in the SWS's fishing activities. If the tournament is postponed due to weather conditions deemed unsafe by SSCF, refunds will not be issued. Please view website for alternate fishing dates and updated tournament details.
